The meeting was held at the premises of the University Roma TRE in Rome, Italy. A chairman of the meeting was Flavio Lombardi, the project representative of the host institution, actively involved in the activities within Work package 1.

Welcome

On behalf of hosting institution, Prof. Flavio Lombardi, together with prof. Roberto Di Pietro welcomed the partners to the third ECESM consortium meeting and presented the University Roma TRE, its premises and organisational structure.

Recap, work progress, presentations

Dr. Marko Holbl, leader of the Work package 1, presented the work done at deliverable 1.1, which has been finished and is ready for online publishing. The discussion about problems, difficulties and sent inputs from partners took place in order to improve the work for future activities.

Also, Ivana Ognjanović, PhD has presented which changes have been done in DEV 1.1 and invited all participants to look at published version. She emphasized that specific methodological approach may be applied in order to prepare scientific analyses and publish it as publication at scientific journal and/or international conference.

Prof. Matjaz Debevc explained that all deliverables should be published at (at least) national level in Montenegro, and therefore the ISSN identifier should be issued. Representatives from both universities from Montenegro accepted main roles in analysing national and institutional requirements for publishing and making informed all partners accordingly.

ACTION 1

University Mediterranean and University of Donja Gorica have to analyse national and institutional requirements for publishing deliverables and getting ISSN identifier. Deadline: next meeting in June.

All the participants made the presentations of the project progress within the work package 1.2.

1. University of Donja Gorica, Olivera Injac presented existing bachelor programs in cyber security and made their classification regarding content, structure and organisation.
2. University Mediterranean, Srdjan Jovanovski presented existing Master and PhD studies in cyber security. Additionally, he presented an overview of informal education as well as advanced techniques used by American forces that are available online.
3. University Roma TRE, Stefano Guarino presented the cyber security associations regarding the DEV 1.2.
4. Buckinghamshire New University, Ioan Dutca presented the rationales for cyber security education, approaches and cyber security education associations in the United Kingdom.
5. Global Center for Cyber Security, Massimo Cappelli
Massimo Cappelli gave an overview of activities in all levels of education in cyber security, ranging from primary schools, to lifelong and informal education.

ACTION 2

Massimo Cappelli has to prepare report with classification of existing approaches on different levels in cyber security education. Deadline: 26.05.2014.

6. University of Maribor, Marko Holbl

Marko Holbl, leader of the Work package 1, presented the work that should be done at deliverable 1.2 in order to prepare for online publishing. It is agreed, similarly to DEV 1.1, Ramo Šendelj (University of Donja Gorica), Ivana Ognjanović (University Mediterranean) and Marko Holbl to be editors of DEV 1.2.

The third ECESM meeting ended at 16:00.

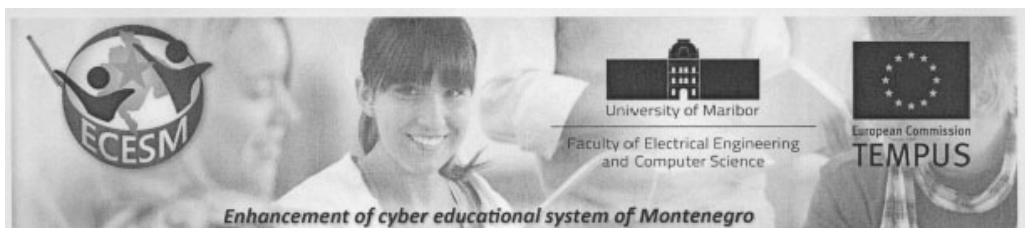
