Topic 1: Joint work on Intermediate Report

Prof. Sendelj presented the content of Intermediate Report and distribution of responsibilities among all partner institutions in its preparation.

Each partner institution shall:

- Prepare financial report about expenditures up to 30th May, 2015
- Prepare report about dissemination activities they organized or participated

Partner institution which is leader of some Working Package shall:

- Prepare description of planned and achieved activities within WP
- Describe obtained results (project deliverables, measurable indicators, etc)

University of Maribor as Project coordinator will coordinate all activities among partner institutions, and Prof. Šendelj invited all Montenegrin partners to actively participate in all activities till end of May when Intermediate Report must be submitted to EACEA.

Topic 2: Participation of all Montenegrin partners in upcoming training activities within WP2 and WP3

Dr. Ognjanović opened discussion about roles of Montenegrin partners in upcoming training activities within WP2 and WP3, which was also one of topics at Coordination Visit with prof.Debevc. All participants agreed that governmental institutions, Ministry of Information Society and Telecommunications and Ministry of Education, as well as Chamber of Economy of Montenegro, should lead organization of training activities (e.g. invitation letters to participants, coordination, pedagogical approaches where applicable, etc.) all in respect to their field of actions at national level.
